

Educate NGOs on regulatory and statutory provisions in a fast-changing landscape facing charitable Institutions. B. Empower NGO teams-key functionaries and finance staff with regulatory compliances now being (a) digital and (b) faceless and C. 360-degree overview to help action 'on the desk'.

### **SESSION PLAN**

The eight Sessions of the Course cover the following topics:

- 1. Code of Taxation for NGOs Charitable purpose, Sections 11-13 of Income Tax Act, new registration/renewal regime as updated.
- 2. Income Tax provisions for charities-Returns, Forms, Proceedings, TDS, and recent changes for charitable institutions. Provisions in Income Tax Bill 2025 for **NGOs**
- 3. FCRA & FCR Rules with latest updates
- 4. Decoding the CSR Law for NGOs
- 5. Social security laws & update on Labor Codes
- 6. GST Law for NGOs
- 7. Securities Law (Social Stock Exchange) for NGOs
- 8. Regulatory Compliance Calendar under various laws for NGOs

The course covers ALL aspects of LAW surrounding operations of an NGO.



#### **CONTENT AND DELIVERY**

The content for each session is generated and delivered through Zoom by Saathi's team which comprises experts like CS Sharad Bhargava who have conducted the course for 3500 NGOs/staff. **Content focuses only on provisions applicable to charitable institutions.** 

8 Session will be held on a fixed day and time per week @1 session per week. The fixed day and time each week will be Friday from 3 to 5 PM. Each session is for two hours with one and a half hours of content delivery followed by 25-30 mins of Q&A.
