THE BODHAN INITIATIVE

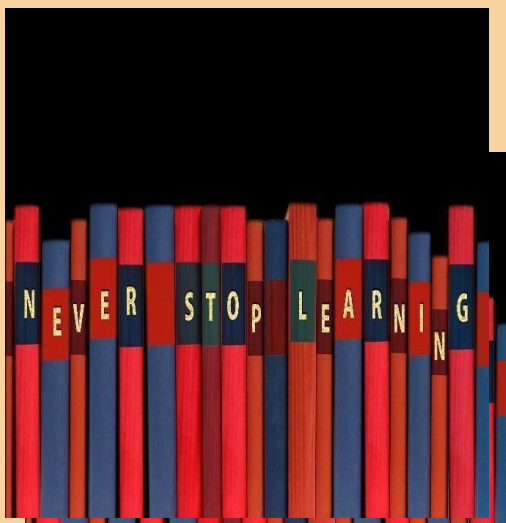

CONTENT AND DELIVERY
